## Equatorial Guinea

### CEIBA FIELD

- ▶ Achieved first oil in late 2000.
- ▶ The Sendje-Ceiba Floating Production Storage and Offloading (FPSO) vessel has:
  - 120,000 barrels of oil per day processing capacity and 135,000 barrels of water per day injection capacity.
  - Current production rate is 45,000 barrels of oil per day from a subsea development.

### OKUME COMPLEX

- ▶ Achieved first oil in late 2006.
  - Production facilities include two TLPs, three fixed platforms and a central processing facility.
  - Oil is exported to the Sendje-Ceiba for storage and sales.

## Libya

### OASIS/WAHA CONCESSIONS

- ▶ Acquired Block 54 in the EPSA IV Round in mid-2005.
  - Concession life extended to 2031-34.
  - Concessions comprise: 22 blocks across 12.9 million acres / 52,000 km<sup>2</sup>
  - Gross production is 335,000 barrels per day.

## Egypt

### WEST MED (BLOCK 1)

- Located offshore Alexandria in 500-1500 meters of water.
- Contains existing discoveries Abu Sir, El King, El Max, Al Bahig and El Dekhila.
- Partners (working interest): Hess (55%), RWE (35%), KUFPEC (10%).

### NORTH RED SEA

- Acquired Q1, 2006.
- Hess interest: 100%.
- Total Area: 9450 km<sup>2</sup> (equivalent to more than 45 Gulf of Mexico blocks).
- New 3D seismic acquired in 2008.

## Algeria

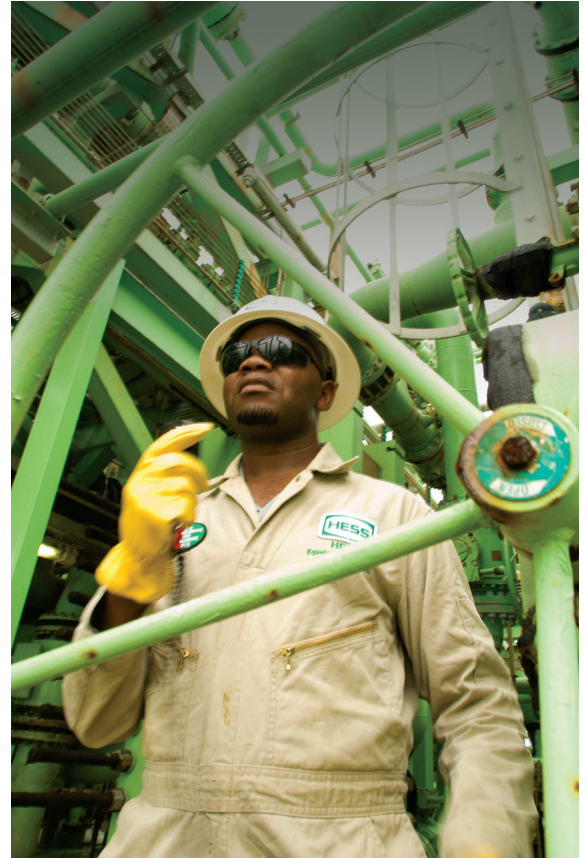
### GASSI EL AGREB

- ▶ Joint venture with Sonatrach (SonaHess) that began in 2000.
  - Located 700 km southeast of Algiers.
  - Two-phase redevelopment project including 3D seismic program, 45 new wells, infrastructure refurbishment, gas compression and reinjection.

## Social Responsibility

- ▶ Hess Equatorial Guinea, Inc. continues with the successful Prodege program, a 10-year educational initiative in which Hess, along with the government, strives to develop a nationwide model for education. Hess is a major partner in helping to educate the children of Equatorial Guinea.
- ▶ Hess is actively supporting Algerian communities with numerous education and health initiatives. Schools and cultural organizations have received donations of computers and printers, and medical equipment was provided to hospitals and volunteer groups.
- ▶ In Libya, the Tripoli staff assisted in the renovation of an orphanage and donated new furniture and toys to the facility.
- ▶ Hess Egypt sponsored the tuition and fees of 65 students to attend a community school in Establ Antar. The company also packaged and distributed over 800 bags of essential food during Ramadan.
