



Hess Corporation has extensive interests in Libya that date back to 1955 when, as part of the Oasis Group, Hess was awarded six concession areas in the Sirte Basin. The first discovery was made in 1962, and by 1970 the concession was producing over one million barrels of oil per day.

The Libyan NOC became a partner in these concessions in 1973 and additional blocks were awarded in 1979. Hess was successful in acquiring Block 54 in the EPSA IV Round in mid-2005. This offshore block was the most sought-after in the round. Hess re-entered its dormant Waha interests in December 2005. The company also opened its new office in Tripoli during 2005.

## **Regional Context**

Hess has a growing portfolio of interests in North Africa. In addition to Libya, Hess has interests in Egypt and Algeria.

- ▶ In Egypt, Hess acquired an interest and has become operator of the Block 1 West Med Deepwater Development Area.
- ▶ Development plans for the cluster of West Med gas discoveries are being formulated.
- ► Exploration potential through additional potential of West Med area and the extensive North Red Sea Area opportunity acquired in early 2006.
- ▶ In Algeria, Hess has a 49% interest in the Gassi El Agreb redevelopment project, a joint venture with Sonatrach that commenced in 2000. Since then, production had doubled. Second phase of Gassi El Agreb development is underway to further enhance output.
- ▶ Plans are being formulated for the development of the BMS discovery on Block 401c.
- ▶ Exploration in Blocks 428 and 429 West Agreb.
- ▶ Beyond these projects, Hess is ready to build on its initial success in the region and is always looking for new business opportunities in North Africa.
